### (a) Amount Beneficially Owned:

As of the date of this Schedule 13G, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), holds 128,579 shares of the Issuer's Common Stock and warrants to purchase 6,015,580 shares of the Issuer's Common Stock. Each warrant entitles the holder to purchase one share of Common Stock from the Issuer at an exercise price of \$11.00 per share ("Warrants"). The Warrants will expire on November 7, 2013, or earlier upon redemption. Notwithstanding the foregoing, pursuant to the Waiver Amendment Agreement and Waiver of Limitations on Exercise of Warrants dated October 14, 2009, the number of shares of Common Stock that may be acquired by Integrated Core Strategies upon exercise of the Warrants is limited to the extent necessary to ensure following such exercise, the total number of shares of Common Stock then beneficially owned by Integrated Core Strategies does not exceed 9.8% of the total number of issued and outstanding Common Stock (including for such purpose the shares of Common Stock issuable upon such exercise. Accordingly, as of the date of this Schedule 13G, Integrated Core Strategies beneficially owns 1,439,646 shares of the Issuer's Common Stock (consisting of 128,579 shares of Common Stock and Warrants to purchase 1,311,067 shares of Common Stock), which represents approximately 9.8% (calculated pursuant to Rule 13d-3), of the outstanding shares of the Issuer's Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.
